When entering into contract with a foreign corporation/trust you understand that you, your person, the corporation you're representing and the man you are dealing with are bound by the laws of the trust and further understand that the policies/jurisdiction of any foreign corporation are not applicable to said trust property and nor does it provide immunity making you liable and lawfully bound by the terms set forth by the trust and in this application both commercially (your bond) and privately.

If you do not comprehend the content herein we suggest you seek legal/lawful counsel and assistance immediately. NOTE: All business/contracting with the person is at the sole discretion and responsibility of the trustee of said trust. The man you are interacting with has **no granted rights** to speak for the person(corporation) of a similar name.

If you have been provided viewing of the **Certificate of Private ID #BTT-001**, you have verbally entered into contract with the trust through your interaction with trust protected property and you have been made aware of the fees associated with the interaction of which rule **a.)Withholding beyond 10 minutes, from Freedom of Life and travel (considered as trespass) is currently active which will incur a value of \$1000 per min beyond 10 minutes.**
