

Let this stand as LAWFUL NOTICE OF PUBLIC OUTRAGE and LETTER BEFORE ACTION;

I, the living man known as Michael-Henry: of the family Furlong, Jus-in-Rem, Sui-Juris, do hereby give formal notice to the aforementioned parties of serious breaches of law, duty, trust, and international covenant against me, the estate under trust, and my immediate family. This notice is issued pursuant to my role as:

- The living benefactor of the private foreign trust res formerly identified as MR MICHAEL FURLONG;
- Secured Party Creditor under recorded filing reference 202503288150154;
- Lawful holder-in-due-course of all rights, title, and interest over my own name, body, mind, soul, and estate.

This document is lawfully sworn under penalty of perjury and gives all relevant parties the opportunity to cure, provide remedy, or rebut the claims made herein within a strict timeframe of Fourteen (14) days from the date of receipt.

- Enforcement of Fee Schedule and lawful lien
- Public exposure and commercial claim
- Referral to international human rights oversight

#### SUMMARY OF LAWFUL BREACHES

1. **TRESPASS UPON THE PRIVATE TRUST ESTATE** Multiple agents (including but not limited to: AGENT 5891) have unlawfully attempted to compel the living man to act as surety for a legal fiction trust without contract, consent, or jurisdiction.
2. **UNLAWFUL ARREST, DETENTION, AND ASSAULT** The affiant was repeatedly detained without a valid warrant, seized from his mother's home, handcuffed, assaulted, headbutted, and denied lawful remedy and process in direct violation of:
  - Police and Criminal Evidence Act 1984 (PACE)
  - Police Act, Section 90
  - ICCPR Articles 7, 8, 9, 16, 18
  - Magna Carta (1215) Article 29
  - c/f: ECHR Article 5
  - Canon 3008
  - Fraud Act 2006, Sections 2, 3, 4, 5.
  - Forgery and Counterfeiting Act 1981
  - Tort of Barratry
  - UNIDROIT (PICC) Article 1
3. **MISFEASANCE & MALFEASANCE IN PUBLIC OFFICE** Numerous officials acted ultra vires by:
  - Refusing to identify themselves
  - Refusing to produce oath or bond
  - Engaging in fraud by misrepresentation and personage
  - Enforcing statutes upon a living man with no lawful joinder

4. **JUDICIAL DISHONOUR BY JUDGE HARRIS** It is on record that Judge Harris entered a plea on behalf of the trust res "MR MICHAEL FURLONG" without lawful consent of the authorised representative, in breach of:
  - Due Process under Common Law
  - Constitutional Limits of Jurisdiction
  - Fiduciary Duty and Trust Law
5. **FRAUD, TRAFFICKING, AND PEONAGE** The undersigned was held in private prison for 15 days under conditions that amounted to peonage, including biometric coercion, unlawful data collection, and denial of access to lawful remedy or jury trial. No valid contract or obligation was ever produced. All subject to fee schedule. To go against the Constitution is Treason.
6. **FAILURE TO PRODUCE LAWFUL WARRANT** Despite multiple DSARs and lawful requests, no valid, wet-ink signed warrant has ever been produced. Digital documents do not constitute lawful process under Criminal Procedure Rules 13.5.2.

FEE SCHEDULE (AS PREVIOUSLY NOTIFIED AND LAWFULLY ATTACHED)

- Unlawful Arrest/Detainment: £1,000 per hour
- Physical Assault or Injury: £10,000 per incident
- Judicial Dishonour: £25,000 flat charge
- Fingerprints: £50,000
- Denial of Jurisdictional Proof or Bond: £10,000
- Fraud by Personage: £9,000 per use of fiction name
- Trespass upon the Trust: £1,000 per occurrence
- Emotional Distress: £10,000
- Data Violation / Unlawful Record Creation: £6,000
- Correspondence £100 per page

Aggregate remedy to date is calculated as exceeding £550,000 and rising.

## NOTICE TO CURE AND REMEDY

All parties addressed above have a lawful duty to:

1. Cease and desist all action against the living man and the Trust Res;
2. Provide full copies of any alleged warrants, bonds, or court orders bearing wet ink signatures;
3. Issue a public apology and confirmation of all record deletions;
4. Settle the outstanding remedy amount to the trust designated account (details available upon demand).

Failure to fulfil all four conditions above within 14 days shall result in:

- Immediate publication of facts to the public domain
- Enforcement of commercial lien and private claim
- Pursuit of justice via International Court or Jury of Peers
