

Writ of Mandamus

Pursuant to the Laws of commerce I require a concise explanation of why the respondents C.E.O namely: THIERRY BOLLORE, is not bound by these laws:

- 1) On or around the 29th of October 2020, Thierry Bollore was served a Notice of Conditional Acceptance to the proposed contract renegotiations relating to mask wearing by way of recorded delivery mail number: NV 5006 3430 2GB delivered on 2nd November 2020. It had a seven-day response time in good faith. No response was received.
- 2) On or around the 9th of November 2020, Thierry Bollore was served a Notice of Dishonour and Opportunity to Cure recorded delivery mail number: NV 5008 1374 5GB delivered on 11th November 2020. It had a seven-day response time in good faith. No response was received.
- 3) On or around the 18th of November 2020, Thierry Bollore was served a Notice of Dishonour recorded delivery mail number: NV 9102 9342 2GB delivered on 20th of November 2020. It had a seven-day response time in good faith. No response was received.
- 4) On or around the 1st December 2020, Thierry Bollore was served a Notice of Security Interest recorded delivery mail number: BN 0164 8664 2GB delivered on 2nd December 2020. It had a seven-day response time in good faith. No response was received.
- 5) The above correspondence was collated into an Affidavit of Obligation and served on Thierry Bollore on or around the 30th December and 4th of January at two separate business locations with a thirty day response time in good faith. No response was received.

- 6) On or around the 5th of February 2021, Thierry Bollore was served a Notice of Fault and Opportunity to Cure recorded delivery mail number: NV 2016 1751 0GB delivered on 8th February 2021. It had a Thirty-day response time in good faith. No response was received.
- 7) On or around the 5th of March 2021, Thierry Bollore was served a Notice of Default recorded delivery mail number: NV 1974 8051 2GB delivered on 8th March 2021. It had a Thirty-day response time in good faith. No response was received.
- 8) Thierry Bollore went into commercial Default, we did send an Affidavit of Service and Nonresponse, recorded delivery number: NV 4122 6393 2GB delivered on 19th March 2021. No response was received at all over 90 days perfecting the Lien.
- 9) On the preliminary phone call the respondents third party: Kate Dodd confessed to Pauline A. Feeney that she had altered a commercial; instrument namely Exhibit 3, on the presumption " He had recorded it", This was a clear breach of Canon 1541: The physical alteration of a document without the permission of the original author is an injury that renders the guilty party immediately liable.

We would like a full concise explanation of why Thierry Bollore is exempt from the laws of commerce and why Pauline A Feeney chose to ignore canon law.

We require these answers within 72 hours from receipt.
